## STEP-OUT TRADING DISCLOSURE

This document provides relevant "step-out" trade information for clients or prospective clients considering wrap fee investment advisory programs offered by MML Investors Services, LLC ("MMLIS" or the "Firm") that utilize models managed by Envestnet Asset Management, Inc. ("Envestnet") and third party investment managers ("Sub-Managers"). Clients in wrap fee advisory programs ("Programs") pay a single, asset-based fee (called the "Total Client Fee") that covers portfolio management services, execution of transactions that are executed through MMLIS and NFS (defined below), clearing and settlement of trades and custody of clients' assets. All terms capitalized but not defined herein shall have the meaning ascribed to them in the MMLIS Terms and Conditions and/or Form ADV brochure, as applicable.

MMLIS, in its capacity as a registered broker-dealer, generally acts as the introducing broker-dealer on trades executed for MMLIS advisory accounts ("Accounts"). In order to participate in MMLIS Programs, clients must establish a brokerage account through the Firm with National Financial Services, LLC ("NFS"), which will act as clearing firm and custodian for clients' assets under the Programs. The Firm has engaged Envestnet to provide advisory, technology and trading services for the Programs. Please refer to the applicable MMLIS Form ADV brochure for more information regarding the applicable Program, including fees and costs associated with Client's Account.

Trades under the MMLIS Programs generally are expected to be effected through the Firm in its capacity as a broker-dealer and cleared and custodied by NFS. In addition, for Programs including models managed by Envestnet or Sub-Managers, Envestnet generally conducts the trading for its models and for Sub-Managers' models through NFS as clearing brokerdealer. If trades are not executed by NFS, which may occur if Envestnet or a Sub-Manager, as applicable, reasonably believes in good faith and consistent with its fiduciary obligations that another broker-dealer will provide better execution, then clients will be subject to execution fees and charges that are in addition to the Total Client Fee for the Program. For securities traded on a principal basis in a dealer market, such as fixed income securities, these additional costs will be reflected in the net purchase or sale price shown on the trade confirmation clients receive following the trade and will not be disclosed separately in the trade confirmation. For securities purchased on an agency basis, the confirmation will show the commission charged for the trade. Whether it is in the form of a dealer mark-up or mark-down or a broker commission, the cost for execution that is incurred when a trade is sent away from MMLIS and NFS for execution will be in addition to the Total Client Fee for the Program.

**Trading Away/ Step-Out Trades.** Envestnet and Sub-Managers may select the broker-dealers that execute trade orders for client accounts. As investment advisers, Envestnet and Sub-Managers have an obligation to seek "best execution" for client trade orders. Envestnet and Sub-Managers must place client trade orders with those broker-dealers that they believe are capable of providing the best qualitative execution, taking into account the full range and quality of the services offered by the broker-dealer. Envestnet and Sub-Managers' best execution obligations do not require the lowest available cost to be obtained for trade orders. Clients should understand that MMLIS does not evaluate whether Envestnet or Sub-Managers are meeting their best execution obligations when sending trades away from MMLIS and NFS (referred to as "trading away" or "step-out trades"). Because MMLIS plays no role in executing trades that are traded away for models managed by Envestnet or Sub-Managers, MMLIS is not able to negotiate the execution costs and charges assessed. The decision of whether to trade away is made solely by Envestnet or the Sub-Manager. Please note that for the MMLIS "Advisor Select" program, MMLIS and its investment adviser representatives generally conduct all trading through NFS. In limited circumstances, MMLIS may engage in step-out trading for Advisor Select accounts in order to seek best execution of client trade orders. For the period of January 1 – December 31, 2023, step-out trades conducted by MMLIS for the Advisor Select program.

Additional Costs to Clients. As noted, when Envestnet and Sub-Managers place client trade orders for execution with a broker-dealer other than MMLIS and NFS and engage in step-out trades, the executing broker-dealer imposes a commission, markup, markdown, or other charge for executing the transaction. Clients will incur trading costs that are in

addition to the Total Client Fee for the Program. As discussed above, a portion of the Total Client Fee paid by clients in a wrap fee program is for the execution of client trades that are sent through MMLIS and NFS for execution. When Envestnet or a Sub-Manager trades away, clients must pay a separate fee for the execution of such trades even though a portion of the Total Client Fee they pay is for trade execution services (i.e., for the execution of trades executed through MMLIS and NFS). Thus, when step-out trades occur clients (i) must pay two fees that are designed (in part or full) to pay for execution services and (ii) are not receiving a portion of the services paid for by the Total Client Fee (i.e., that portion of the Total Client Fee that pays for execution services provided by MMLIS and NFS). However, it is important to recognize that Envestnet and Sub-Managers trade away when they believe that they can achieve better execution results by trading away.

Step-out trading practices differ between Envestnet and different Sub-Managers, in part, due to the different type of securities they buy and sell and the trading market dynamics for such securities. As a result, Envestnet and some Sub-Managers do not engage in step-out trading for particular models, while others may step-out most or all transactions for other models. Generally, Sub-Managers that engage in step-out trades will be more costly to a client than Sub-Managers that do not engage in step-out trades. Clients should review the Sub-Managers' Form ADV Part 2A Brochure, inquire about the Sub-Managers' trading practices and associated trading costs, and consider this information carefully before selecting a Sub-Manager.

Please note that the information below reflects historical data and may not be indicative of the current frequency with which Envestnet or Sub-Managers trade away or the related costs of such trades to clients. Envestnet's or a Sub-Manager's past trading away practice is not necessarily indicative of future trading away practices. Included below is a list of models managed by Envestnet and Sub-Managers which have been identified as including step-out trade activity. Clients should review these step-out trading practices and their affiliated costs with their advisors. Clients may also wish to contact their advisor to determine if other Sub-Managers on the platform manage a similar strategy at a lower cost. The information listed below does not reflect step-out trading practices in which Envestnet or Sub-Managers may engage when positions transfer in-kind to a new account within an advisory program. In such cases, depending on the holdings, Envestnet or Sub-Managers may engage in step-out trading for the purpose of selling existing positions and reinvesting the proceeds in accordance with the strategy selected by the client.
